Morning Comments March 3, 2009

Despite the sharp declines yesterday, equity prices reflected almost no sign of panic as once again investors shuffled out the doors in an orderly fashion. We believe this complacent behavior is jacking up risk levels quickly with both longs AND shorts increasingly at risk. SPX prices easily closed below the level from which we thought some stabilization would emerge at 735 and are bearing down on intermediate term targets that we had thought awaited some corrective action to be realized. We are completely uncomfortable and feel risks of dislocation are rising and while the bias to dislocation remains clearly to the downside we are reluctant to play the momentum short game at such a late stage in the sell off given the proximity of our intermediate term price targets. Many defensive areas of the market that have resisted selling pressure over the last few months have collapsed in the past few days including healthcare, pharma, consumer staples, biotech and utilities. We believe this is late stage action and evidence of a maturing decline. There are no real signs to get long aside from clear oversold conditions but these are too flimsy to risk capital on at this point.
